1 EXECUTIVE SUMMARY

This summary report describes the **progress made by the Member States in implementing the RDP evaluation plans over the calendar year 2017**. The summary is based on the screening of Chapter 2 of 115 annual implementation reports (AIRs) submitted to the European Commission in 2018. Overall, the 115 AIRs submitted in 2018 show a high level of completeness of the Chapter 2 'progress in implementing the evaluation plan'. This is for example reflected by 97% of AIRs containing at least two filled sub-sections of Chapter 2 compared to the 89% submitted in 2017.

Modifications to the RDP evaluation plan have decreased by 30% compared to the previous reporting period. In total, 34 modifications were mentioned in 11 AIRs submitted in 2018. In the context of these modifications, RDP Managing Authorities mainly updated the timeline of the evaluation plan, provided further details on governance and coordination aspects (e.g. establishment of an 'Evaluation Advisory Group' in IT NRN), and adapted evaluation topics and activities (e.g. feasibility assessment of instruments to contrast extreme weather events in UK Wales).

The total number of reported evaluation activities (508) has increased by almost 36% in 2018. The activities concerned all phases of the evaluation cycle, from planning, preparing, conducting evaluations to reporting findings and taking follow-up actions. The biggest increase of activities compared to the previous year was observed in the preparing and structuring phase (+17%). Moreover, the share of activities related to conducting evaluations and disseminating findings increased slightly by +5% and +6%, while the reporting on planning and coordination activities has largely decreased (-31%).

Activities on the provision and management of data have slightly increased. 298 data-related activities have been reported in 2018 compared to 281 activities in 2017. The largest share of activities was on preparing the data provision and management (47%), followed by activities related to the conducting phase (36%), and the planning phase (17% of the total). Many RDPs reported activities related to building or updating data and information systems (76) and data collection (74). Data-management activities in relation to counterfactual analysis were mentioned only in few reports (5).

The number of completed evaluations (192) has increased by 28% compared to 2017 and the overall majority (89%) was published online. More than half of the completed evaluations (66%) were linked to the major EU evaluation milestones and requirements (e.g. 8% to ex post evaluations of RDPs 2007 – 2013, 6% to the ex-ante evaluation of RDPs 2007 – 2013, 43% to enhanced AIRs submitted in 2017, and 9% to the preparation of the enhanced AIRs to be submitted in 2019). Furthermore, self-standing evaluations (27%) on other specific RDP aspects, such as delivery mechanisms, financial instruments, technical assistance were reported, as well as evaluations on other rural issues (7%) such as rural tourism and biodiversity.

The highest share of completed evaluations concerned those evaluations that covered several of the six RDP priorities (40%), followed by evaluations covering only RDP Priority 4 'Restoring, preserving and enhancing ecosystems' (14%). Relatively few evaluations (13%) have been completed in relation to Priority 1 'Knowledge transfer and innovation', Priority 2 'Farm viability and competitiveness', Priority 3 'Food chain organisation and risk management', Priority 5 'Resource-efficient, climate-resilient economy' and Priority 6 'Social inclusion and economic development'. Completed evaluations were reported also on specific thematic areas (15%), such as innovation (e.g. BE Flanders), environment (e.g. ES Castilla-Mancha, FI – Mainland), and climate change (e.g. UK England). The Member States reported also evaluations on the RDP delivery mechanism (3%), RDP monitoring and evaluation system (3%), and other topics (12%), such as studies on certain rural issues and dynamics (e.g. biodiversity, rural tourism).

The extent of reporting on evaluations findings has overall increased: 79 AIRs contained summaries of completed evaluations (compared to 65 in 2017). Within these summaries, 471 distinct evaluation findings could be identified covering different topics. Following the same trend observed in the completed evaluations above, more than half of the evaluation findings (67%) were linked to one or more RDP priorities and focus areas. Among these evaluation findings, the highest share concerned the RDP Priority 4 'Restoring, preserving and enhancing ecosystems' (21%), followed by Priority 2 'Farm viability and competitiveness' (11%), Priority 6 'Social inclusion and economic development' (10%), Priority 1 'Knowledge transfer and innovation' (7%), Priority 5 'Resource-efficient, climate-resilient economy' (6%), and Priority 3 'Food chain organisation and risk management' (4%). Evaluation findings covering multiple RDP priorities and focus areas (8%) concerned more general aspects of the RDP 2014 - 2020, such as the internal and external coherence of the RDP intervention logic (ES Madrid), good practices observed across the supported projects (ES Aragon), and the challenges in achieving the targets set up in the RDP (SI).

Moreover, 14% of the evaluation findings were connected to other specific thematic areas, such as EIP-AGRI operational groups, NRN, innovation, or RDP synergies with other ESI funds. To a smaller extent, evaluation findings also covered the RDP management and delivery mechanism (8%), RDP monitoring and evaluation system (6%), and other topics (5%), such as ex post evaluation of RDPs 2007 - 2013.

The communication activities in relation to publicising evaluation findings have increased by 23% compared to the previous reporting period. 344 communication activities were reported in 2018, reaching out to 3.97 million stakeholders. These were targeted mainly through websites (3.04 million stakeholders reached), publications and evaluation reports (0.23 million), but also through other channels (e.g. written consultations, newsletters etc.). The most frequently used communication channels included public meetings such as workshops and conferences (128 reported activities), internal meetings involving the RDP Managing Authority, Monitoring Committee, Evaluation Steering Groups, or Paying Agency (93 activities), and website (70 activities).

The follow-up given to evaluation results increased by more than three times in number compared to those reported in the AIRs submitted in 2017 (from 169 to 544). Three quarters of the reported follow-up activities were based on the findings obtained from the enhanced AIRs submitted in 2017, 10% based on self-standing evaluations on the RDP management and delivery mechanism, and still 9% on the ex post evaluation of RDPs 2007-2013 as well as and other completed evaluations (e.g. ex-ante evaluation of RDPs 2014-2020). More than one third of the follow-ups (36%) concerned improvements of the RDP delivery mechanisms, followed by adjustments of the RDP intervention logic (23%), adaptations in the RDP monitoring and evaluation system (23%), and other types of activities (18%) such as drawing general conclusions and recommendations, describing lessons learned or evaluation findings, or providing justifications for not undertaking any follow-up activities.

2 INTRODUCTION AND METHODOLOGY

Starting in June 2016, and for every year until 2024, Managing Authorities shall submit to the European Commission an Annual Implementation Report (AIR) on the implementation of their Rural Development Programme (RDP). The AIRs submitted in June 2018 covers the calendar year 2017. Chapter 2 of the AIR provides information about the progress concerning the implementation of the RDP evaluation plan.

This summary report aims to: (1) analyse the information reported in chapter 2 of the AIRs submitted in 2018, and (2) draft a synthesis of the Member States' progress in implementing the evaluation plans, which are part of their RDP.

The summary report is based on a quantitative and qualitative content analysis of chapter 2 of the AIRs submitted in 2018. The methodology, tools and overall analysis have been conducted by the European Evaluation Helpdesk for Rural Development. The screening and extraction of the information reported in Chapter 2 was carried out by an EU-wide team of 26 geographical experts in RDP evaluation.

Chapter 3 of this summary report lays out the findings on the progress made by the Member States in implementing the RDP evaluation plan. The structure follows the seven sub-sections of chapter 2¹ of the AIRs submitted in 2018, namely:

- a) description of any modifications made to the evaluation plan in the RDP during the year, with their justification;
- b) description of the evaluation activities undertaken during the year;
- c) description of activities undertaken in relation to the provision and management of data;
- d) list of completed evaluations, including references to where they have been published on-line;
- e) summary of completed evaluations, focusing on evaluation findings;
- f) description of communication activities undertaken in relation to publicising evaluation findings;
- g) description of the follow-up given to evaluation results.

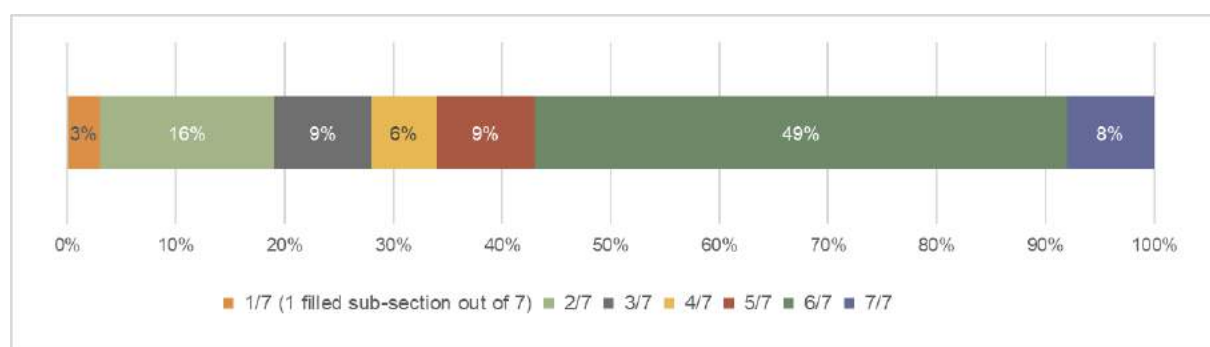
Chapter 4 presents an overall assessment of the progress in implementing the evaluation plan, as well as specific areas and recommendation for better reporting. Finally, the annex displays the full list of the completed evaluations reported in sub-section d), including also the hyperlinks where the reports have been published online, if available.

3 THE PROGRESS IN IMPLEMENTING THE EVALUATION PLANS

Overall, the 115 Annual Implementation Reports (AIRs) analysed in 2018 show a high level of completeness of the Chapter 2 'progress in implementing the evaluation plan'. This can be observed in the number of sub-sections that are filled in Chapter 2 of the AIRs. Although the overall number varies across the different RDPs, 97% of AIRs contained at least two filled sub-sections of Chapter 2 compared to the 89% reported in 2017. 3% of the AIRs presented only one filled sub-section.

Figure 1 shows that more than 50% of the AIRs submitted in 2018 presented six or seven filled sub-sections. Sub-section c) was completed in each submitted AIR, followed by sub-section b) *Evaluation activities* (97% of the AIRs). Sub-sections d) *Completed evaluations*, e) *Summary of completed evaluations*, f) *Communication activities*, and g) *Follow-up given to evaluation results* were filled in about 70% of the AIRs submitted in 2018. The least filled sub-section was a) *Modification to the evaluation plan* (11 AIRs in total).

To understand the overall progress made by the Member States in implementing the RDP evaluation plan, Figure 2 provides an overview of some selected trends in the information reported in each sub-section of Chapter 2, by comparing the AIRs submitted in 2017² and 2018.

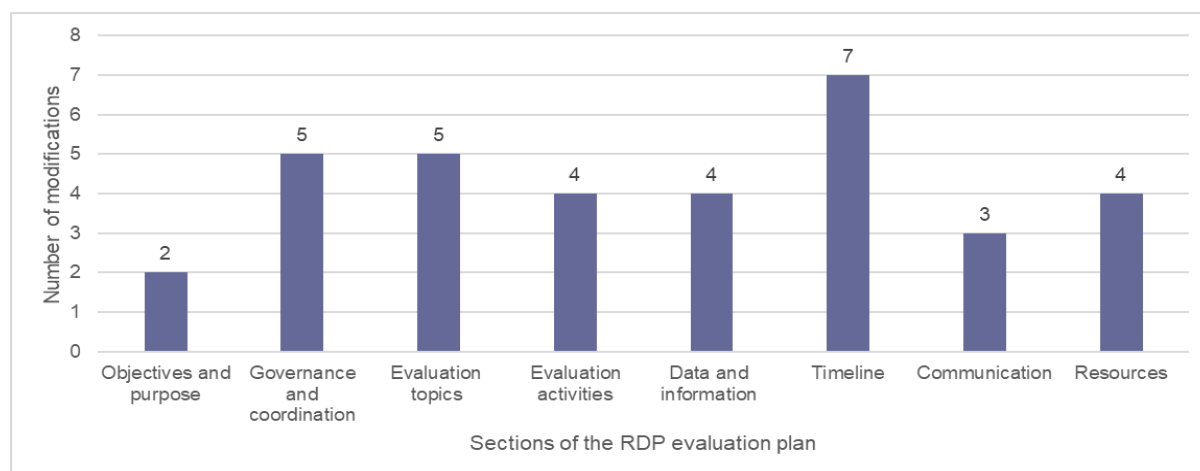

Figure 2 shows that apart from sub-section a), the overall level of information reported in the AIRs in 2018 has increased in almost all the sub-sections of Chapter 2. This increase becomes particularly evident in the higher number of reported activities in sub-section f) *Communication activities* and sub-section g) *Follow up given to evaluation results*.

3.1 Sub-section a): description of any modifications made to the evaluation plan in the RDP during the year, with their justifications

Modifications to the RDP evaluation plan have decreased by 30% compared to the previous reporting period. 34 modifications were reported in 11 AIRs submitted by five Member States in 2018. Almost half of the modifications were reported by the RDP ES Castilla Leon and ES National. Overall the modifications concerned all eight sections of the RDP evaluation plan (see Figure 3).

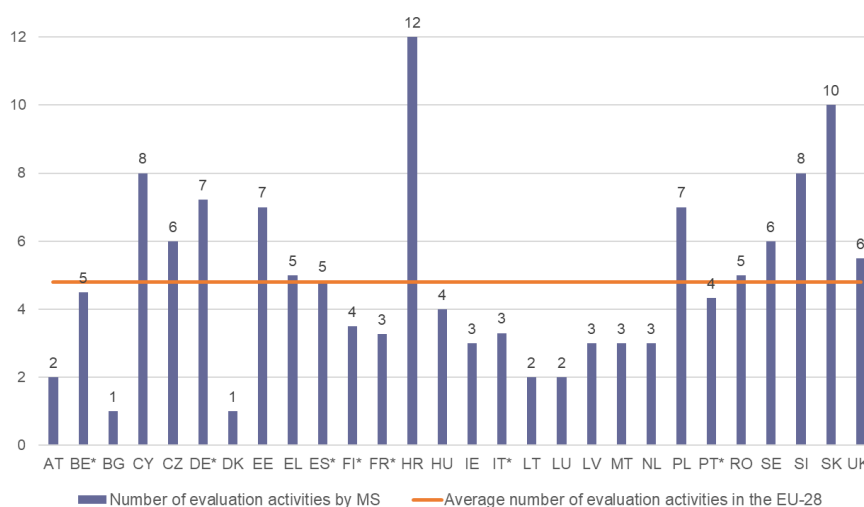
More in detail, the reported modifications concerned:

- **timeline (7):** e.g. adaptations of timetables and evaluation milestones based on the level of RDP uptake (e.g. DE Schleswig-Holstein) or the selection of an independent evaluator (e.g. IT Calabria);
- **governance and coordination (5):** e.g. adjustments to the frequency and composition of governance meetings. In FR Rural Network the number of Rural Network Committee’s meetings was reduced; in UK Wales an evaluation advisory group was established; and in ES Castilla-Leon additional actors and experts were included;
- **evaluation topics (5) and activities (4):** In IT Trento a thematic evaluation on ‘*livestock in mountain areas*’ was replaced by an evaluation on the ‘*management of financial instruments*’, in UK Wales an additional study on the feasibility of agri-insurance schemes to contrast extreme or catastrophic weather events was introduced;
- **data and information (4):** e.g. more detailed descriptions on data storage, maintenance, and management, as well as more specifications on the modalities and timelines for specific thematic assessments (i.e. national risk management and technical assistance programme in France).
- **communication (3):** e.g. further descriptions on the content, target, and structure of the communication section of the RDP evaluation plan. In ES Castilla Leon and ES National programme the target actors and communication channels were further specified, UK Wales developed a webpage as part of the NRN website to share the evaluations conducted by the LAGs;
- **resources (4):** e.g. IT Sicily increased the resources for monitoring and evaluation activities, ES National addressed the training and capacity building needs of the personnel involved in RDP monitoring and evaluation;
- **objectives and purpose (2):** e.g. ES National introduced the objective to promote the transparency in the RDP evaluation, and integrate the recommendations from the ex post evaluation of RDPs 2007 – 2013.

3.2 Sub-section b): description of the evaluation activities undertaken during the year

The number of reported evaluation activities has increased by almost 36% to 508 in 2018. Many evaluation activities were undertaken for the enhanced AIR submitted in 2017. Figure 4 shows the number of reported evaluation activities per Member State with average values for the regionalized countries.

Figure 4. Number of evaluation activities reported by the Member States* (N=508).



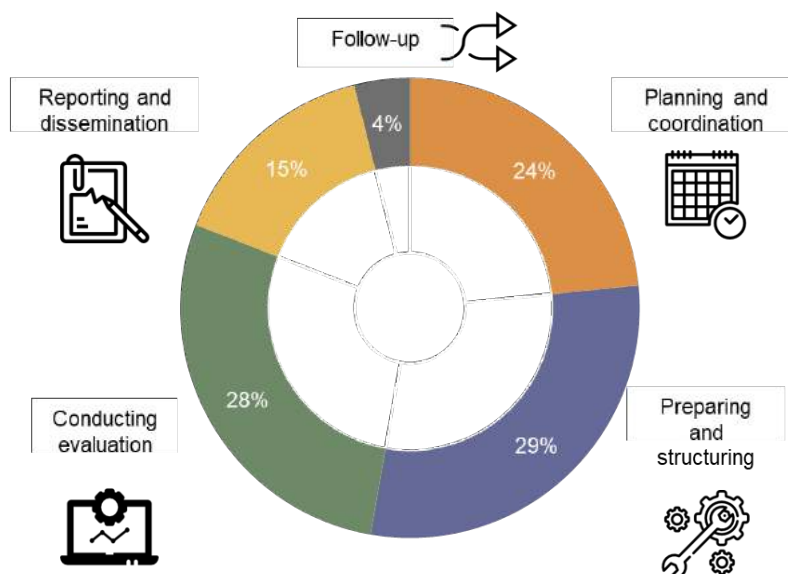

SK and HR are the Member States with the highest number of reported evaluation activities in the AIRs submitted in 2018 compared to the EU-28 average (orange line), while BG and DK are among those who reported only few evaluation activities in sub-section b).

The evaluation activities can furthermore be related to the various phases of the evaluation cycle (see Figure 5).

The largest share of evaluation activities concerned the preparation and structuring phase (29%), followed by those dealing with conducting the evaluations (28%), planning and coordination (24%), reporting and dissemination (15%), and follow-up (4%). Compared to the previous reporting period, the biggest increase was observed in evaluation activities of the preparing and structuring phase (+17%). Moreover, the share of activities related to conducting the evaluations and disseminating their findings increased slightly by +5% and +6%. The reported planning and coordination activities have largely decreased (-31%). Some examples of the reported evaluation activities for the different phases are shown in the following:

Planning and coordination:

- **setting up thematic and evaluation steering groups** (e.g. ES Aragon, ES Castilla-Leon, IT Rural Network);
- **drafting terms of reference and contracting the functionally independent evaluator** (e.g. FR Auvergne, FR Bretagne, IT Puglia);
- **commissioning and coordinating thematic evaluations** (e.g. UK Wales, IT Piemonte);
- **setting up evaluation elements for the CAP 2021 – 2027** (e.g. FR Rhone-Alpes).

Preparing and structuring:

- developing the evaluation framework and methodologies (e.g. BE Wallonia, BE Flanders);
- screening data sources and information availability (e.g. HR, HU)
- building or updating the RDP monitoring and information system (e.g. CZ, EL, IT Calabria);

- defining and reviewing evaluation elements, such as indicators, tools, templates (e.g. DE Brandenburg/Berlin, DE Rhineland-Palatinate, EL, ES La Rioja);
- building evaluation capacity (e.g. SK, PT Mainland, MT).

Conducting evaluation:

- **data collection** (e.g. ES Andalucía, FR Franche-Comte, UK North of Ireland);
- **assessment of RDP focus areas' achievements** (DE Lower Saxony/Bremen, IT Provincia Autonoma di Bolzano, PL);
- **conducting thematic evaluations** (e.g. DE Thüringen on Animal Welfare, UK England on agri-environment schemes, PT Mainland on “simplified cost option”).
- **triangulating evaluation findings** (UK Wales).

Reporting and dissemination:

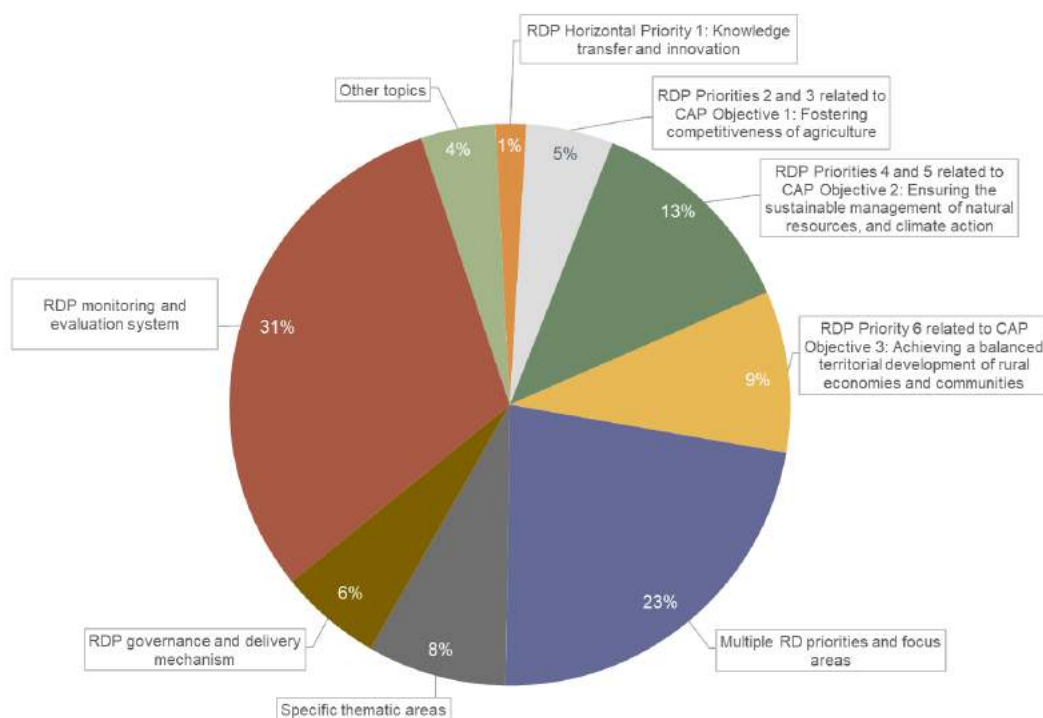
- reporting findings and lessons learnt from the ex post evaluation of RDPs 2007 – 2013 (e.g. BG, SE, UK England) or IPARD programme (HR);
- reporting findings to the Commission through the enhanced AIRs submitted in 2017 (DE Mecklenburg-Vorpommern, ES Castilla-Leon, IT Basilicata);
- presenting findings to various RDP stakeholders, such as Monitoring Committee (e.g. ES Pays Vasco, FI – Åland);
- disseminating evaluation findings and information for evaluation capacity building (e.g. EL National Rural Network, IT National Rural Network).

Follow-up:

- improving and adapting the RDP management and delivery mechanism (e.g. ES Extremadura)
- reviewing and upgrading the RDP monitoring and evaluation system (e.g. FR Rhone-Alpes)
- addressing the Commission’s observations to the AIRs (e.g. ES Extremadura, IT Sicily)
- adapting the RDP intervention logic, targets, and budget (e.g. DE Nordrhein-Westfalen)

Furthermore, evaluation activities covered different topics, as shown in Figure 6.

The largest group of evaluation activities was directly linked to the assessment of the *RDP priorities and focus areas* (together 51%). Within this group, 23% of the evaluation activities concerned multiple RDP priorities and focus areas. Furthermore, evaluation activities were specifically linked to RDP Priority 4 '*Restoring, preserving and enhancing ecosystems*' (11%), Priority 6 '*Social inclusion and economic development*' (9%), and RDP Priority 2 '*Farm viability and competitiveness*' (4%). To a lower extent, evaluation activities dealt also with RDP Priority 1 '*Knowledge transfer and innovation*' (1%), Priority 3 '*Food chain marketing, animal welfare, risk management*' (1%), and Priority 5 '*Resource efficiency, and climate resilient economy*' (2%). Evaluation activities on LEADER/CLLD concerned several aspects, such as the preparation of evaluation frameworks and information systems for the LAGs, the support to the LAG's self-assessment activities (e.g. DE Mecklenburg-Vorpommern), or the analysis of the CLLD strategies (e.g. DE Saxony).

The second largest share of evaluation activities concerned the *RDP monitoring and evaluation system* (31%), such as fine-tuning evaluation concepts, upgrading the data and information system, or analysing and ensuring data quality.

Conversely, a relatively small number of the reported evaluation activities was focused on *specific thematic areas* (8%), such as:

- the effectiveness of RDP technical assistance (e.g. CY)
- the promotion of equality between men and women and non-discrimination in the RDP implementation³ (e.g. DE Schleswig-Holstein, ES La Rioja)
- National Rural Network (e.g. IT NRN, FI Mainland, ES National Programme)
- synergies among RDP Priorities (IT Piemonte) and between RDP and other programmes supported by the ESI Funds (e.g. SE and FR Pays de la Loire)
- RDP cross-cutting objectives related to climate change (e.g. ES Castilla-Leon), environment (e.g. SI, UK England), and innovation (e.g. ES La Rioja, DE Sachsen).

To a similar extent, 6% of the evaluation activities focused on the assessment of the *RDP management and delivery mechanisms*, such as carrying out beneficiary surveys to assess their experience with the selection process (e.g. DE Lower Saxony/Bremen) or analyses of the costs of RDP delivery system (e.g. ES Extremadura, DE Lower Saxony /Bremen).

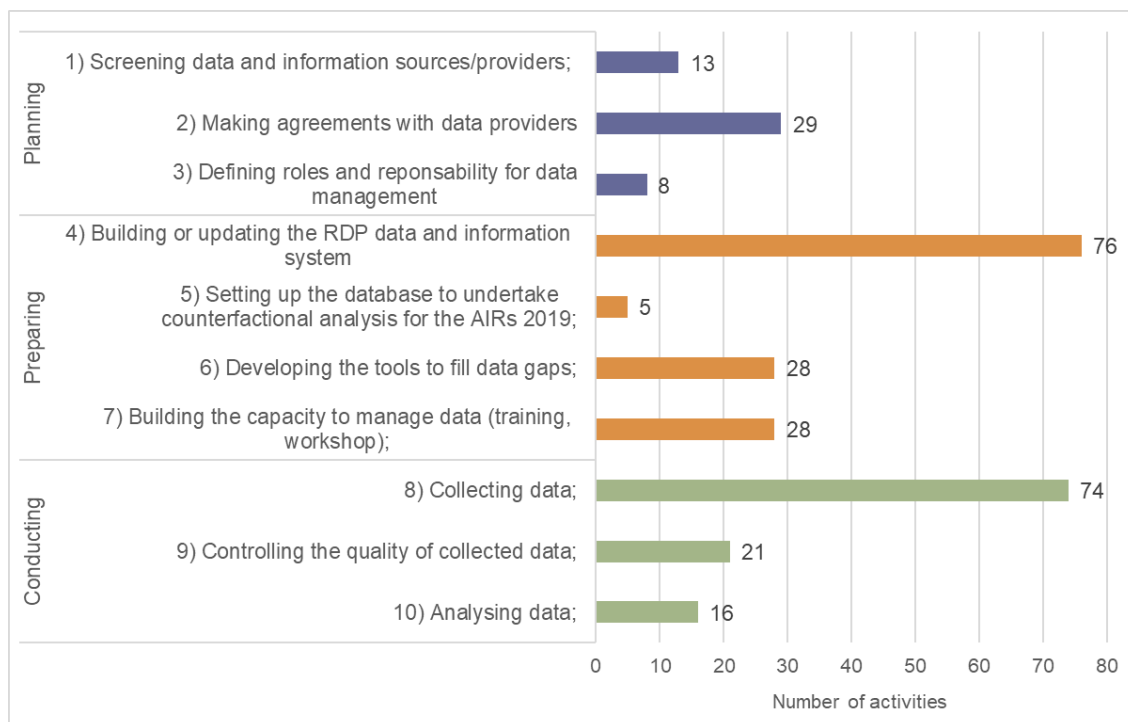
Finally, 4% of the evaluation activities focused on other topics, such as the ex post evaluation of RDPs 2007 – 2013 (e.g. BG), the ex-ante evaluation of financial instruments (e.g. IT Calabria, IT Puglia), or the assessment of RDP schemes for refugees' employment and skills support in rural areas (UK Wales).

3.3 Sub-section c): description of activities undertaken in relation to the provision and management of data

Activities in relation to the data provision and management have slightly increased compared to the previous reporting period. In total, 298 activities were reported in the AIRs submitted in 2018. Figure 7 illustrates the distribution of the reported activities across three main phases of data management (planning, preparing and conducting).

Most of the reported activities in relation to data provision and management were related to the preparing phase (47%), mainly the building and updating of the data and information system of the RDP, followed by the activities to fill data gaps and to build capacity. The conduction phase (36%) shows a strong data-collection activity in the Member States (double compared to the previous reporting period). Comparably few activities (17%) concerned the planning of data-management. Within this phase, Member States mostly were concerned with making agreements with data providers.

Some activities concerned already data provision and management for the next AIR to be submitted in 2019 (Box 1).

Box 1. Examples of reported activities in relation to data provision and management for the AIRs in 2019

Planning activities were undertaken in Slovakia to ensure data for the environmental impact indicators to be assessed in 2019. Agreements were signed between the Managing Authority and the Soil Science and Conservation Research Institute (SSCRI) to transfer data on the trends in soil erosion and soil organic matter. In Lithuania, the Managing Authority signed an agreement with the Lithuanian Ornithological Society for a research on '*bird population in agricultural land*'. The results of the study will be used for the AIR to be submitted in 2019, as well as in the RDP ex-post evaluation.

Preparatory activities included interviews with a small sample of RDP beneficiaries to test an online survey for the AIR to be submitted in 2019 in France (Picardie); the development of concepts and timeline for collecting additional indicators linked to agri-environmental measures for the AIR in 2019 and the ex post evaluation in 2024 (Thuringen, Germany). In United Kingdom (England), existing surveys were explored to carry out the counterfactual analysis of socio-economic schemes in 2019 (e.g. Farm Business Survey, Farm Practices Survey, and Longitudinal Small Business Survey).

Conducting activities (i.e. data collection, analysis, quality check) were reported from Finland (Mainland) and concerned the collection and publication of the updated values for the common CAP and RDP impact indicators ([link](#)). Information on the collection of data on the Common Impact Indicators 35 (Farmland birds index) was reported also from Croatia and Slovenia.

3.4 Sub-section d): list of completed evaluations, including references to where they have been published online

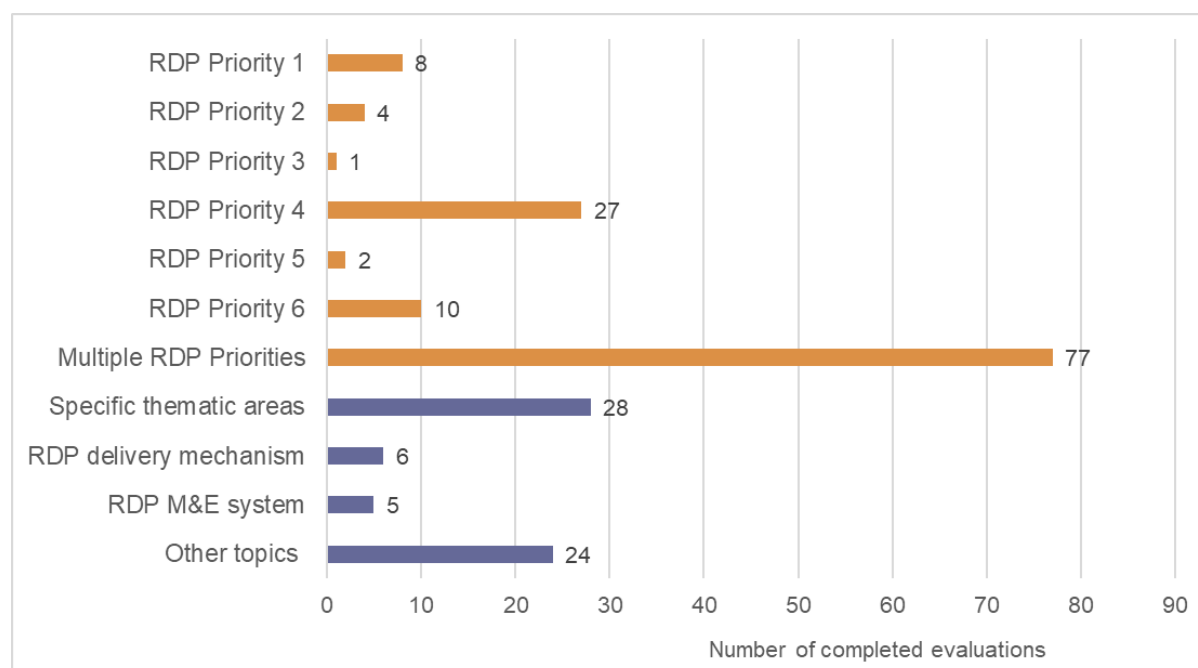
The annex presents the full list of completed evaluations across topics, including hyperlinks.

The number of completed evaluations (192) increased by 28% compared to 2017 and the overall majority (89%) was published online. More than half of the completed evaluations (66%) were linked to the *major EU evaluation milestones and requirements* (i.e. 8% to ex post evaluations of RDPs 2007 – 2013, 6% to the ex-ante evaluation of RDPs 2007 – 2013, 43% to enhanced AIRs submitted in 2017, and 9% to the preparation of the enhanced AIRs to be submitted in 2019).

Furthermore, *self-standing evaluations on other specific RPD aspects* were reported (27%), such as delivery mechanisms, financial instruments, technical assistance, as well as evaluations on *other rural issues* (7%), such as rural tourism and biodiversity.

More than half of the completed evaluations (67%) were directly linked to the RDP priorities and focus areas as shown in Figure 8 (see orange bars).

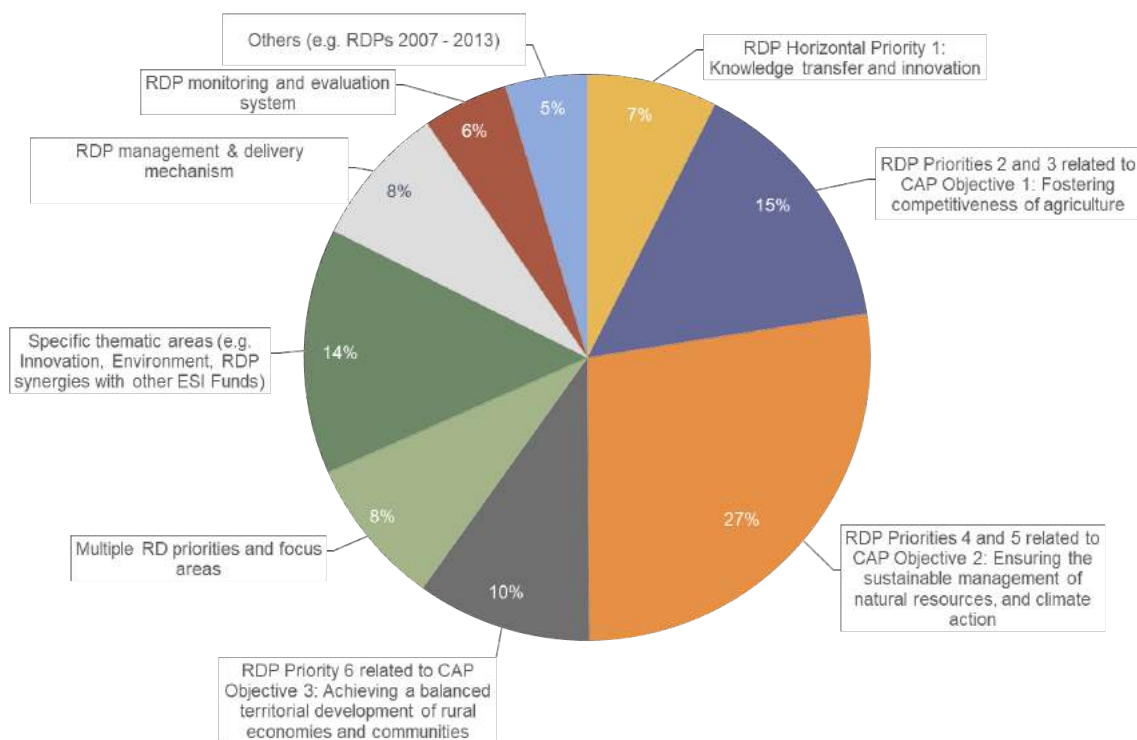
Within this group, the highest number of completed evaluations concerned *multiple* RDP priorities and focus areas (77), due to the high number of enhanced AIRs submitted in 2017 which were reported by many Member States in sub-section d). Many completed evaluations (27) covered the RDP Priority 4 “*Restoring, preserving and enhancing ecosystems*”. Relatively few evaluations have been completed in relation to Priority 6 ‘*Social inclusion and economic development*’ (10), Priority 1 ‘*Knowledge transfer and innovation*’ (8), Priority 2 ‘*Farm viability and competitiveness*’ (4), Priority 5 ‘*Resource-efficient, climate-resilient economy*’ (2), and Priority 3 ‘*Food chain organisation and risk management*’ (1).

In addition, completed evaluations (28) were reported also on specific thematic areas, such as innovation (e.g. BE Flanders), environment (e.g. ES Castilla-Mancha, FI – Mainland), and climate change (e.g. UK England). To a lower extent, completed evaluations addressed also the RDP management and delivery mechanism (6), RDP monitoring and evaluation system (5), or other topics (24), such as studies on certain rural issues and dynamics (e.g. biodiversity, rural tourism, impacts of RDPs 2007 – 2013).

3.5 Sub-section e): summary of completed evaluations, focusing on evaluation findings

The extent of reporting on evaluations findings showed an overall increase: 79 AIRs contained summaries of completed evaluations (compared to 65 in 2017). Within these summaries, 471 distinct evaluation findings could be identified covering different topics, as shown in Figure 9.

Following the distribution pattern of the completed evaluations presented above, also more than half of the reported evaluation findings (67%) were linked to one or more RDP priorities and focus areas. Among these evaluation findings, the highest share concerned again the RDP Priority 4 'Restoring, preserving and enhancing ecosystems' (21%), followed by Priority 2 'Farm viability and competitiveness' (11%), Priority 6 'Social inclusion and economic development' (10%), Priority 1 'Knowledge transfer and innovation' (7%), Priority 5 'Resource-efficient, climate-resilient economy' (6%), and Priority 3 'Food chain organisation and risk management' (4%). Evaluation findings covering multiple RDP priorities and focus areas (8%) concerned more general aspects of the RDP 2014 - 2020, such as the internal and external coherence of the RDP intervention logic (ES Madrid), good practices observed across the supported projects (ES Aragon), and the challenges in achieving the targets set up in the RDP (SI). Box 2 provides an overview of reported findings linked to the RDP priorities and focus areas.

Figure 9 shows that further 14% of the evaluation findings were connected to other *specific thematic areas*, such as EIP-AGRI operational groups, NRN, innovation, or RDP synergies with other ESI funds. To a smaller extent, evaluation findings covered the *RDP management and delivery mechanism* (8%), *RDP monitoring and evaluation system* (6%), and *other topics* (5%), such as ex post evaluation of RDPs 2007 - 2013.

Box 2. Overview of reported findings linked to the RDP priorities and focus areas

- For **CAP Objective 1: Fostering competitiveness of agriculture** the evaluation findings (15% of the total), covered both the implementation and the achievements of RDP Priority 2 and 3. Member States were able to capture the trends in farm productivity and modernisation in supported farms (e.g. ES Navarra, FR Bourgogne), the changes in the farm net value added (e.g. AT, BG, ES Galicia), the contributions to the generational renewal (e.g. ES Galicia, ES La Rioja, IT Bolzano), as well as observations on the level of uptake registered in 2017 (e.g. CZ, ES Extremadura, FR Auvergne).
- For **CAP Objective 2: Ensuring the sustainable management of natural resources, and climate action** the evaluation findings (27%) addressed the implementation and achievements of RDP Priority 4 and 5. In relation to RDP Priority 4, several Member States reported on the trends of the Farmland Bird Indicator (e.g. CY, EE, SI), the changes in the content and dynamics of soil nitrates and sulphates (e.g. EE, DE Saxony, IT Piedmont), and the implementation of agri-environmental schemes (UK England, FR Mayotte, ES La Rioja). For RDP Priority 5, evaluation findings demonstrated the RDP support to carbon conservation and capture (e.g. ES Galicia, ES Navarra, SK), the effects on carbon emissions' reductions (e.g. IT Trento, PL), renewable energy (e.g. LV, ES La Rioja), and investments in energy efficiency and water management (e.g. ES Murcia, FR Bourgogne, IT Bolzano).
- For **CAP Objective 3: Achieving a balanced territorial development of rural economies and communities** the evaluation findings (10%) mainly described the implementation of Priority 6, with a focus on LEADER/CLLD (e.g. PT Madeira, BG, EL, ES Valencia) and the support given to Local Action Groups for implementing, monitoring and evaluating the LEADER/CLLD strategies (e.g. PT Azores, IT Puglia, HR, CY).
- The findings related to the horizontal **RDP Priority 1: Knowledge transfer and innovation** concerned the level of uptake (e.g. IT Puglia, ES Galicia), the selection criteria and aspects of the RDP delivery mechanism (IT Bolzano, ES Navarra, IT Trento), as well as the positive contributions towards all RDP priorities (e.g. PT Mainland).
- Evaluation findings covering **multiple RDP priorities and focus areas** (8%) concerned more general aspects of the RDP 2014 - 2020, such as the internal and external coherence of the RDP intervention logic (ES Madrid), good practices observed across the supported projects (ES Aragon), and the challenges in achieving the targets set up in the RDP (SI).

The reported findings on **specific thematic areas** concerned for example the RDP effects on enhancing, conserving, maintaining, or detracting rural landscape (UK England); gender sensitive projects which promote social inclusions and poverty reduction (DE Saxony); the role of the NRN in increasing the participation of stakeholders in RDP activities and projects, as well promoting innovation in the agri-food and forestry sectors (e.g. BE Flanders, ES National, RO); the consistency and synergies between RDP and other regional policies (e.g. FR Provence-Alpes-Côte d'Azur), and the contribution of technical assistance to the RDP management and evaluation (e.g. CY, ES Valencia, etc.).

The findings on the **RDP management and delivery mechanism** covered multiple aspects of the RDP implementation, such as: the level of uptake, selection criteria, and committed expenditure of several RDP measures (UK Scotland, IT National Rural Network, FR Provence-Alpes-Côte d'Azur), as well as the level of satisfactions among beneficiaries (e.g. DE Schleswig-Holstein).

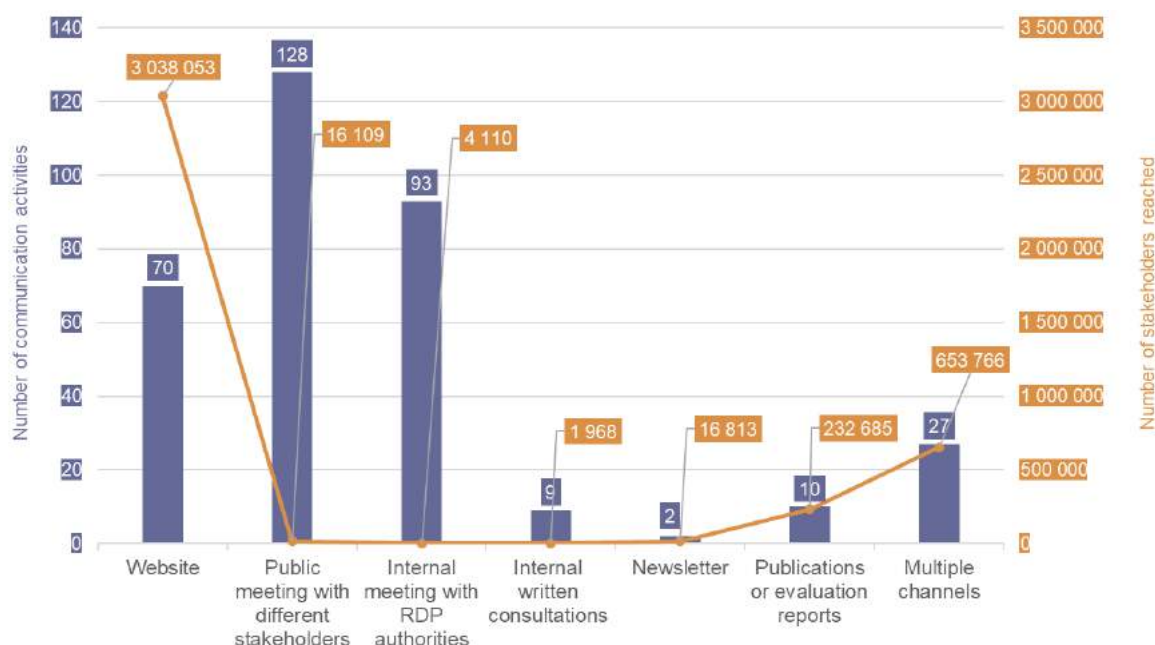
Evaluation findings on the **RDP monitoring and evaluation system** discussed the quality of additional indicators for assessing the RDP communication strategy and achievements (e.g. PL, UK England), the availability of indicators to assess the secondary contributions of RDP focus areas (e.g. ES Castilla-Leon); and the data and information system (e.g. PT Azores, AT, ES Murcia).

Finally, evaluation findings were reported also in relation to **other topics**, such as the ex-ante evaluation of financial instruments (IT Calabria), the suitability of the integrated territorial development approach to respond to the needs and specificities of the territory (FR Pays de la Loire); or the analysis of the social media used by the farmers (BE Flanders).

3.6 Sub-section f): Description of communication activities undertaken in relation to publicising evaluation findings

The communication activities in relation to publicising evaluation findings increased by 23% compared to the previous reporting period. In total, 344 communication activities were reported in 2018, reaching out to 3.97 million stakeholders. Figure 10 shows that the stakeholders were reached mainly through websites (3.04 million), publications and evaluation reports (0.23 million), but also through other channels (e.g. written consultations, newsletters etc.)

Figure 10. Communication activities and stakeholders reached per type of channel (N=344)



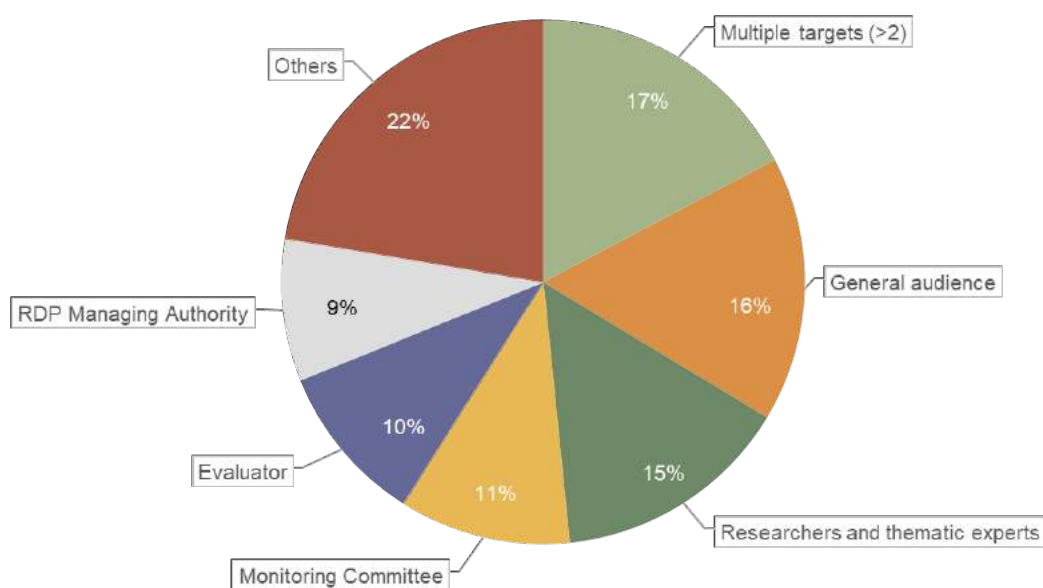

The most frequently used communication channels included public meetings such as workshops and conferences (128 reported activities), internal meetings involving the RDP Managing Authority, Monitoring Committee, Evaluation Steering Groups, or Paying Agency (93 activities), and the website (70 activities). To a lower extent, communications were implemented through multiple channels (27), publications or evaluation reports (10), internal written consultations (9), and newsletters (2).

Most of the communication activities were organized by the RDP Managing Authority (47%), followed by national or regional governmental authorities (13%), research institutions (9%), National Rural Networks (8%). Other stakeholders, such as LAG networks, RDP Monitoring Committee and evaluation steering groups organized the remaining 23% of communication activities.

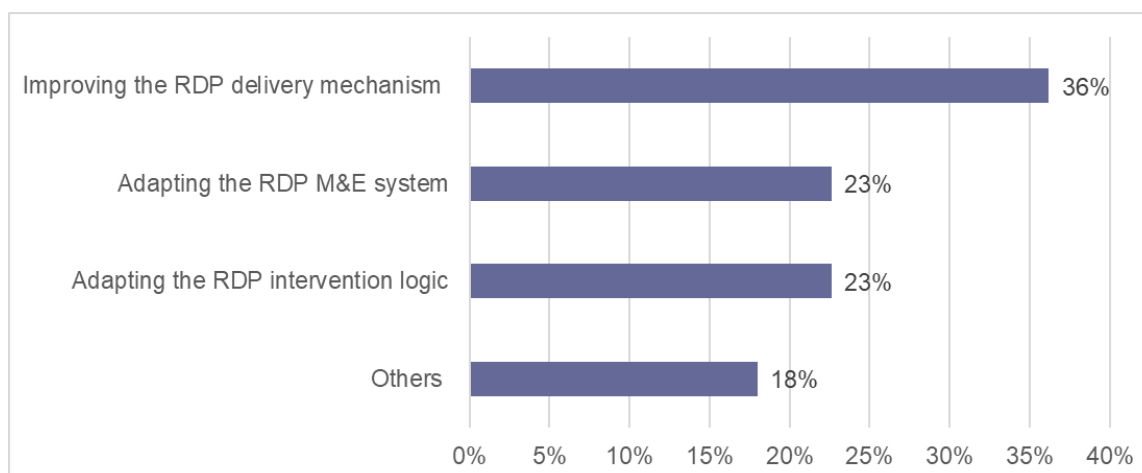
Figure 11 shows that the largest shares of communication activities addressed more than one target group (17%) and the general audience (16%). Furthermore, the communication activities targeted researchers and thematic experts (15%), Monitoring Committee (11%), evaluators (10%) and the Managing Authority (9%). Other stakeholders were targeted to a smaller extent (22% in total). These include: Local Action Groups, National Rural Networks, European Innovation Partnership – Operation Groups, National or regional authorities (e.g. ministries, paying agencies), RDP beneficiaries, and RDP evaluation steering groups.

The 344 communication activities addressed different target groups, as shown in Figure 11.

3.7 Sub-section g): description of the follow-up given to evaluation results

The follow-up given to evaluation results increased by more than three times compared to the numbers reported in the AIRs submitted in 2017 (from 169 to 544 in 2018). Almost three quarters of the reported follow-up activities were based on the findings obtained from the enhanced AIRs submitted in 2017, 10% based on self-standing evaluations on the RDP management and delivery mechanism, and still 9% on the ex post evaluation of RDPs 2007-2013, as well as on other completed evaluations (e.g. ex-ante evaluation of RDPs 2014-2020).

Figure 12 shows the distribution of follow-up activities given to evaluation results according to different type of actions.

More than one third of the follow-up activities (36%) aimed at improvements in the RDP delivery mechanisms, such as aligning timelines and accelerating procedures (e.g. CZ, ES Madrid), designing or updating the RDP communication strategy (in CY and PL), and streamlining administrative procedures for the selection of beneficiaries (e.g. DE Brandenburg/Berlin, DE Saxony).

The second largest share of follow-up activities (23%) concerned adjustments of the RDP intervention logic, such as modifying the financial allocation to RDP measures (e.g. CZ, ES Andalucía, IT Veneto), adapting the selection criteria (e.g. IT Piedmont, DE Bayern), or changing RDP targets (DE Sachsen-Anhalt).

To the same extent (23%), follow up activities dealt with adaptations of the RDP monitoring and evaluation system, e.g. reviewing indicators (e.g. ES Murcia, LU, PL), providing capacity building actions (e.g. PL, FI – Mainland), fine tuning evaluation concepts (e.g. DE Thuringen), revising or designing evaluation methods (DE Sachsen-Anhalt), and planning and preparing the enhanced AIRs to be submitted in 2019 (ES Castilla-Mancha, SI, IE).

18% of the reported follow-ups concerned 'other' types of activities, such as drawing general conclusions and recommendations, describing lessons learned or evaluation findings, or providing justifications for not undertaking any follow-up activities.

4 OVERALL ASSESSMENT

4.1 Summary assessment on the implementing of the evaluation plans in 2018

Based on the information reported in the AIRs submitted in 2018, it can be concluded that **most of the Member States made substantial progress in implementing the evaluation plan**. This can be observed in the higher number of evaluation activities, completed evaluations, communication activities and follow-ups reported in 2018 compared to the previous reporting period.

The evaluation activities undertaken by the Member States in 2017 dealt largely with preparing and conducting evaluations (57% in total), especially for the AIRs submitted in 2017. On the other hand, the number of reported activities concerning planning and coordinating evaluations decreased compared to the previous reporting period (-31%). Activities on disseminating findings from the ex post evaluations of RDP 2007 – 2013 or ex-ante evaluations of RDP 2014 – 2014 were also reported in several cases.

A slightly higher number of activities in relation to data provision and management was reported in 2018 (from 281 in 2017 to 298 activities). The reported activities on data collection almost doubled compared to the previous reporting period. To a similar extent, activities on building or updating the RDP data and information system were also reported (77). While most of the activities dealt with planning, preparing, and implementing the data management systems for the AIRs submitted in 2017, Member States reported also numerous activities focused on the AIRs to be submitted in 2019 (e.g. signing agreements with data providers, preparing surveys, collect impact indicators).

The number of completed evaluations increased compared to the previous reporting period (+28%). Although a great number of completed evaluations were linked to the major EU evaluation milestones and requirements (i.e. ex post and ex-ante evaluations or AIRs), the Member States conducted also numerous self-standing evaluations related to other RDP aspects or rural issues (e.g. delivery mechanism, monitoring and evaluation, biodiversity).

The reported evaluation findings addressed several topics and were focused on different level of analysis (e.g. impacts, results, outputs). Following the same trends observed in the completed evaluations in terms of topics addressed, most of the findings were linked to the RDP priorities and focus area, especially RDP Priority 4 “*Restoring, preserving and enhancing ecosystems*”.

The number of reported communication activities significantly increased (+23%) compared to the previous reporting period, reaching out to 3.97 million stakeholders. The most frequently used communication channels were: *public meetings* such as conference and workshop; *internal meetings* involving the RDP Managing Authorities, Monitoring Committee, and Evaluation Steering Groups; and *websites*. Many of these activities were targeted to a wider audience and multiple target groups (e.g. researchers, evaluators, beneficiaries, citizens).

The number of follow-ups given to evaluation findings largely increased (from 169 to 544), and one quarter of the reported follow-up activities were based on the findings obtained from the enhanced AIRs submitted in 2017. Follow-up activities were reported in relation to improving the RDP delivery mechanism, adapting the RDP monitoring and evaluation system, and adjusting the RDP intervention logic.

4.2 Specific areas to be observed

Despite the overall increase in the number of information reported in the AIRs submitted in 2018, specific areas of improvement can be observed with a view of better reporting on the progress in

implementing the RDP evaluation plan. Specifically, the analysis of the information reported in Chapter 2 was challenging in the following situations:

- Reported information sometimes referred to calendar years different from 2017;
- Unnecessary repetitions across various sub-sections of Chapter 2, e.g. between the abstracts of completed evaluations in sub-section d) and the summary of completed evaluations, with a focus on findings, in sub-section e);
- Missing hyperlinks to published evaluations or communication activities, or reported hyperlinks that lead to generic websites in which the right information is difficult to access;
- Conclusions and recommendations were reported instead of clear follow-up activities in section g).

4.3 Recommendations on better reporting

Based on the specific areas observed above, the following recommendations for better reporting in the AIRs can be given to Member States:

- Report only the information corresponding to the previous calendar year (i.e. the progress made in 2018 should be reported in the AIRs to be submitted in 2019);
- Describe evaluation activities in a synthetic and straightforward manner (e.g. avoid describing the whole process behind a main activity);
- Avoid repetitions among sub-sections. For instance, do not repeat the same information in the abstracts of completed evaluations to be reported in sub-section d) and in the summaries of completed evaluations to be reported in sub-section e).
- In sub-section e), the summary should focus mainly on findings, possibly described in a concise and systematic manner (e.g. provide numbers with a unit of measurement);
- Ensure that the reported hyperlinks work, and that the information can be easily accessed;
- In sub-section g), focus only on follow-up actions undertaken, without listing the conclusions and recommendations of evaluations.
