Programme

Dear NRN colleagues,

The current programming period is fast approaching to its end, and preparations for the 2014-2020 period are well underway in most Member States and regions. This is the time to start to look back on what we achieved, learn from our successes and mistakes, and start to plan our activities for the next programming period in a fresh new spirit.

The Polish NRN with support from ENRD organises the 19th NRN Meeting and Peer-to-Peer Training (combined into a two-day programme between the 11 & 13 September 2013) in Gdansk with a view to the future.

The overarching theme for this event will be 'planning NRN structures, activities and resources' for the next programming period. During the NRN meeting, participants will be provided with specific information on the new regulatory framework, NRN involvement in partnership agreements, and how different NRNs (national and regional networks) are structured and try to reach out to local stakeholder groups.

According to Article 55 of the new draft regulation, the role of national rural networks will be expanded and strengthened in 2014-2020. Although no final guidance has yet been developed on the most appropriate and effective approaches to network resource planning, there is considerable accumulated experience within existing national and regional NSUs.

Module 4 of the peer-to-peer training aims to build on this experience, and will provide opportunities for NSUs, managing authorities and other stakeholders to share among themselves existing knowledge and experience on 'network resource planning'. The main method used for generating peer-to-peer learning between participants will be group-learning, involving resource planning for a hypothetical NRN 2014-2020.

Learning from previous experience, we took account of feedback from previous NRN meetings and pilot training modules. Therefore, the agenda for this event allows more time for in-depth discussions and reflection by the participants.

As with previous NRN events, the success of this meeting will very much depend on your active participation.

We look forward to seeing you all in Gdansk.

Peer-to-Peer Training Module 4: NETWORK RESOURCE PLANNING

Context

Work is already well underway in most Member States on preparation of the rural development programmes for 2014-2020, including consideration of the structures and operational set-ups that will be used to deliver the expanded and strengthened role¹ of the national rural networks in accordance with Article 55 of the EAFRD legislative proposals.

According to the Commission's *Working Paper on Elements of strategic programming* for the period 2014-2020, the RDPs currently being drafted should include the main elements of the NRN action plan, provisions for its management and budgetary allocation. Indicative financial tables for the networks should then make a clear distinction between the network support unit (NSU) needed to run the network and the cost of implementing the Annual Work Plan (AWP). Additional requirements apply to Member States with regional programmes submitting a separate programme for their networks.

Objectives of Training Module

The **specific objectives** of Training Module 4 are to:

- bring together representatives of national and regional NSUs to share amongst themselves existing knowledge and experiences about resource planning for NRNs;
- use a hypothetical case study to facilitate the development of deeper insights and group learning regarding NRN resource planning for the forthcoming 2014-2020 programme period, and;
- capture / harvest 'Expert Tips for NRN Resource Planning' from participants for broader dissemination notably via the NRN Tool-kit² on the ENRD website.

Learning Outcomes

At the end of Training Module 4 it is anticipated that:

- All participants in the Training Module will have acquired new knowledge and insights about resource planning that can be effectively applied to enhancing the management and operation of their own NSU and national / regional network;
- Guidance notes on NRN resource planning (and possibly other useful materials from the participants) will have been collected for the on-line 'NRN Tool-kit' at: http://enrd.ec.europa.eu/networks-and-networking/nrn-toolkit/en/nrn-toolkit en.cfm, and;
- DG AGRI and the ENRD Contact Point will have a clearer understanding of the practical resource management issues faced by NSUs.
